Non-compete Laws: Virginia COMMON LAW Under Virginia case law, a non-compete agreement must be reasonable A reasonable non-compete is:

No more restrictive than necessary to protect the employer's legitimate business interest Not unduly burdensome on the employee's legitimate efforts to earn a livelihood Consistent with sound public policy
